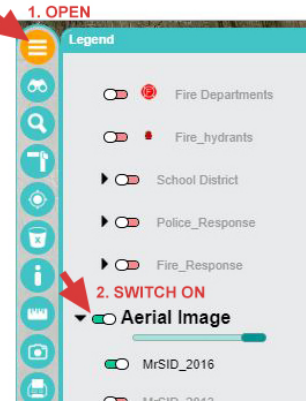

Your project drawings must illustrate the following:

1. Please include the property address and the name of the property owner.
2. Your drawing should illustrate the location of all the property lines, the primary structure, and any existing accessory structures on the property.
3. Please show the placement of any existing or proposed fence and clearly show the distance from all property lines to the proposed fence. If the fence will be placed directly on the property line please show that on your plot plan.
4. Include any adjacent streets to the property and the names of those streets.
5. Please note the length of each section of fence to be installed on the plot plan.

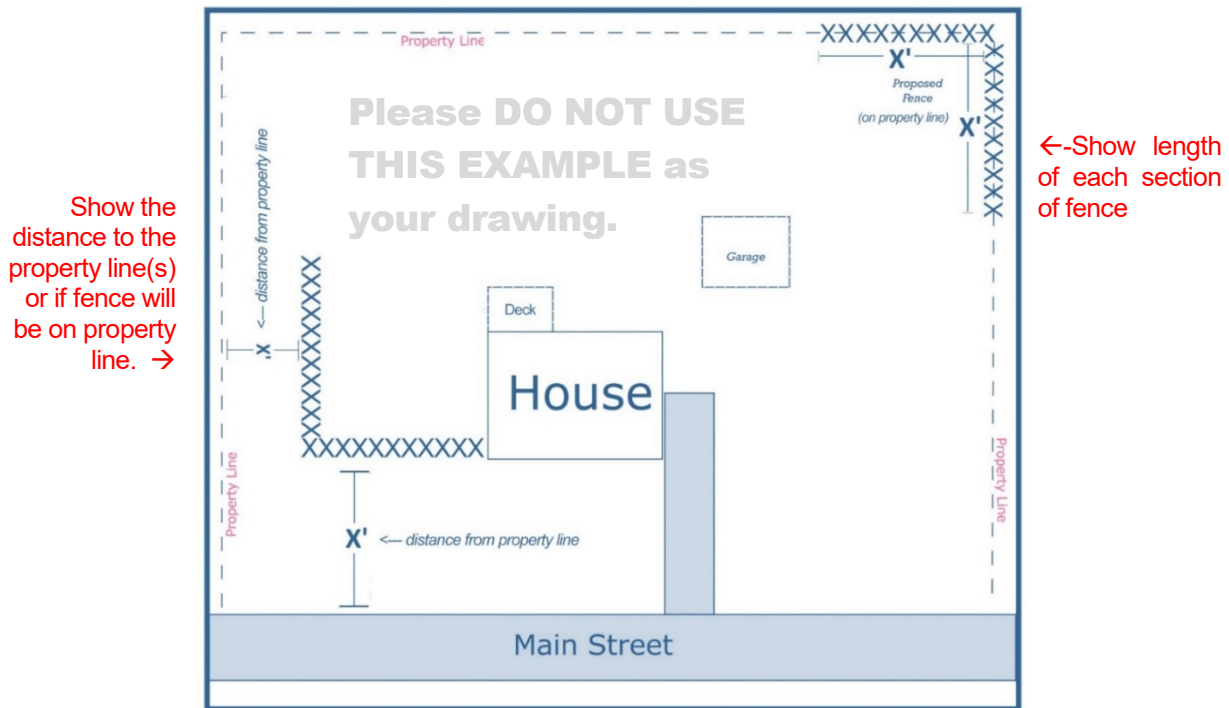
Plot Plan Drawings:

If you are unsure where your property lines are located, you can hire a professional surveyor. You may also look up available property information on the [Montgomery County Auditor's website at mcrealestate.org](https://www.mcrealestate.org). Click on the [house/ruler icon](#) located next to the property detail screen to [view a map](#) of the property. (*Note: Once you have opened the map feature, you can turn on the "aerial" option in the menu. See image right to see how.)

Plans for zoning certificate applications may be hand drawn and need not be to scale.

General Fence Guidelines:



- ✓ Fences may be no taller than (6) six feet in the side or rear yard of a property.
- ✓ Fences no taller than 42" may be located in the front yard (if you have a more unique shape lot, such as a corner lot, you may have what is considered multiple front yards.)
- ✓ Please note that any land existing between the fence to the edge of the property line must be maintained by the property owner.
